
The Internal Academic Audit of the department of CSE conducted on 14/05/2019 by the following Internal Academic Audit Committee (IAAC) committee.


- Dr. Major Singh Goraya, HOD CSE Convener


Following were the suggestions of the IAAC


- Efforts be made to obtain the funded Research projects and consultancy.
- The number of quality publications (SCI/Scopus indexed etc) need improvement
- To opt a standard format of the course file in the department and follow OBE system.
- Course content should be reviewed by the concerned faculty at the end of the semester and a review report must be included in the course file for further consideration during BOS.
- GATE/ competitive examinations syllabus must be included in the schemes and efforts should be made to improve the number of GATE qualified students.
- A standard format of the Lab manuals should be adopted along with list of precautions with each experiment.
- Efforts should be made to improve the placement.
- Measures be taken to improve the class attendance.
- Fast learner and slow learner students be identified and accordingly facilities ~~to~~ be extended.
