

### OFFICE ORDER

1. Consequent upon the recommendations of the Shop Allotment Committee, the Competent Authority has observed that some of the shopkeepers are not displaying the rate list approved by the Institute and it is apprehended that they are charging different rates. Therefore, all the shopkeepers are instructed to display the rate list at the appropriate visible place and not to charge more than approved rates. In case any shopkeepers found indulged in charging of higher rates, then appropriate fine will be imposed besides other disciplinary action.
2. Further all shopkeepers are once again instructed not to use plastic carry bags of any size and stop selling soft drinks & drinking water in less than one liter bottle. Strict action will be initiated against defaulters.
